TRAINING PROVIDERS CIRCULAR NO. 6/2010 PAYMENT OF TRAINING GRANTS THROUGH E-DISBURSEMENT SYSTEM

1.0 **PURPOSE**

1.1 The purpose of this Circular is to inform training providers registered with Pembangunan Sumber Manusia Berhad (PSMB) on the requirement to register with the e-disbursement system for the payment of training grants, effective 1 November 2010.

2.0 **BACKGROUND**

- 2.1 Under the e-disbursement system, the amount of training grant approved for payment would be credited directly into training providers' bank accounts. With the implementation of the system, the issue of cheques being delivered late, lost in mail, late presentation to banks and re-issuance of cheques would not arise.
- 2.2 On 16 August 2010, PSMB has issued an Employer Circular No. 17/2010 informing employers registered with PSMB on the requirement to register with e-disbursement system before 1 January 2011. Employers who do not register with e-disbursement system are not eligible for training incentive and application for training grant under SBL-Khas Scheme will not be approved. Claims for training grant reimbursement effective 1 January 2011 will also be rejected.

3.0 IMPLEMENTATION

3.1 Training providers are required to register with e-disbursement system by 31 October 2010. Training grant claim submitted by training providers who do not register with the e-disbursement system after 31 October 2010 will be rejected. Effective 1 January 2011, application for training grant under SBL-Khas Scheme by employers will not be approved if employers and training providers not register with e-disbursement.

3.2 To register, please submit the E-disbursement Registration Form (PSMB/e/disbursement/10) attached together with this circular to the Finance Division of PSMB. Training providers are required to inform PSMB of any changes concerning their bank account details by submitting a new registration form. PSMB shall not be held liable for any losses due to wrong payment of training grants if the information provided in the registration form is invalid or has changed.
