



## HRD Corp Takes Pledge to Combat Corruption

**PUTRAJAYA, 18 April 2025** - The Human Resource Development Corporation (HRD Corp), in its continued commitment to upholding integrity and good governance, held a corruption-free pledge ceremony - ***Majlis Tatakelola Cemerlang dan Ikrar Bebas Rasuah (IBR)*** today at the Ministry of Human Resources (KESUMA).

The ceremony served as a powerful affirmation of HRD Corp's zero-tolerance stance against corruption and its dedication to strengthening a transparent, accountable and ethical work culture.

The pledge recitation was led by HRD Corp's Chairman Datuk Abu Huraira Abu Yazid and was joined by HRD Corp's Board of Directors, the Senior Leadership Committee and departmental representatives. The ceremony brought together over 100 participants, signifying the organisation's united determination to enhance governance practices, prevent abuse of power and malpractice, as well as to ensure full compliance with government directives.

Held at KESUMA's multipurpose hall, the event was witnessed by the Chief Commissioner of the Malaysian Anti-Corruption Commission (MACC) Tan Sri Dato' Sri Haji Azam Baki. In his address, Datuk Abu Huraira Abu Yazid highlighted the importance of building a high-integrity work culture through institutionalised and responsible leadership.

"We strive to create an environment that not only encourages integrity but institutionalises it as a core value within our organisation," he concluded.

Another key highlight of the event was the sharing of the ***Buku Panduan Integriti HRD Corp*** to Tan Sri Dato' Sri Haji Azam Baki, published in both Bahasa Melayu

and English. The handbook will be distributed to employees as part of the organisation's ongoing efforts to instil ethical values and strengthen its fight against corruption.

Human Resource Development Corporation (HRD Corp) was established in 1993 as the Human Resources Development Council. It was incorporated into Pembangunan Sumber Manusia Berhad through the enactment of the Pembangunan Sumber Manusia Berhad Act 2001.
